

- 2. The people of California are best served by a continuous effort to minimize risks associated with pest management.





- Label amendments on registered products that have a new major uses/sites





# California County Agricultural Commissioners



- Local enforcement by County Agricultural Commissioners and their 400 biologists in the field.
- DPR provides approximately \$27 million per year to CACs for pesticide enforcement and training. They conduct about 17,000 inspections per year.




# **DPR Urban Monitoring Locations**



**Storm drains** 





# **Pyrethroid Surface Water Regulations**

- Went into effect in July 2012
- Requirements for professional applicators, including landscape maintenance
- Non-agricultural use prohibitions and restrictions on
  - Application methods
  - Location and size of application area




## **New Labels For Fipronil Products**

#### California Restrictions (EPA approved 4/10/17)

- Do not apply to garage door or driveway
- Do not apply between Nov 1 and Feb 28
- Do not apply more than 4 times per year
- Do not apply bandwidth more than 6 inches up/out from foundation
- Only use 0.03% dilution
- Do not re-apply at intervals less than 60 days

#### **Neonicotinoids**

#### Completed a risk determination document as required

- Based on maximum application rates and 90<sup>th</sup> percentile residues that cause adverse effects
- Risk determination identified various risks to several crops
- Need to review more submitted studies to develop mitigation measures
- Two years to develop mitigation measures

#### **Cannabis**

- The regulation of cannabis in California is in its infancy stage and will continue to evolve over time.
- DPR continues to work closely with the CACs, state departments, and other stakeholders to meet its legislative mandates.
- There are no pesticides specifically registered for use on cannabis or tolerances established for pesticides on cannabis.
- DPR provides guidance to cannabis cultivators and the Bureau of Cannabis Control



# **Sulfuryl Fluoride**





## **Sulfuryl Fluoride Timeline**

- 2006: DPR completed a health risk assessment of potential toxic effects and exposure
- 2007: DPR listed SF as a toxic air contaminant and established a regulatory target concentration
- 2010 2013: Aeration procedures modified (CAP 1 and CAP 2) to address occupational exposures
- 2014 2018: Evaluate and mitigate potential bystander exposures to infants and children



## **Sulfuryl Fluoride Mitigation**

- DPR's Human Health Assessment Branch reviewed new toxicology data
- ❖ DPR revised the risk management directive: proposed new target 0.41 ppm
- DPR received new scientific information to address uncertainties on the risk management directive
- ❖ Regulatory target level will be finalized after DPR reviews and evaluates information.



#### DPR Registration Branch processes research authorizations for pesticides:

- "With the exception of those persons exempted by 3 CCR section 6268 (see below), a written authorization for research must be obtained from the director prior to any experimental, unregistered use of a pesticide.
- "A research authorization (RA) allows a company to gather data on efficacy, phytotoxicity, residue, environmental effects, methods of application, or other field data to support California registration under California use conditions.
- "RAs are limited by federal regulations to 10 acres or less if the product or proposed use is not federally registered (40 CFR, Part 172). If the product and the proposed use are federally registered, there is no limitation set in California law or regulations, prohibiting DPR from issuing a RA for any size test plot.



- In addition to a RA, a person must obtain a federal Experimental Use Permit for use of an unregistered pesticide/use on 10 or more acres.
- Changes have been made to the process over the last decade, that have improved accountability and oversight for RA's



#### **Increased accountability:**

	Re-designed RA forms	"Failure to comply with any of the conditions of this authorization pursuant to 3 CCR §§ 6260-6272 could result in revocation of the authorization and an administrative fine up to \$5,000 for each time a condition or regulation is violated (Food and Agricultural Code § 12999.5)."
	Database now flags over due reports (Researcher may be restricted from requesting new RA's)

- U.S. Executive Order 12088- does not provide states the authority to require compliance with state regulatory pesticide laws on Tribal lands.
- In California, the state delegates the role of pesticide enforcement and investigations to the County Agricultural Commissioner (CAC).



- Collaboration.
- DPR has an oversight role to make sure that California regulations and Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA) are being complied with.
- Tribal Liaisons provide the bridge between U.S. EPA and the CAC's.






- Communication.
- Exchanging and sharing information about concerns or questions about activities that could be occurring in an area where a tribe would have a concern.
- Taking this information and contacting the appropriate entity.





- Collaboration.
- Making sure that requests from tribes are brought to the attention of the individual who has the authority to make the decisions.





- Accountability.
- Attending meetings.
- Follow through on questions that have been asked in these interactions.






