20 PROOF, by testimony, having been made before me by Pedro Campos submitted to the  
21 court on the 16<sup>th</sup> day of December, 1997;

22 THAT THERE IS REASON TO BELIEVE that there exists APN 108-090-02, Pray Road,  
23 Redding, conditions of non-conformity with the Health <sup>4</sup> and Safety Code regarding asbestos,  
24 that there is an authorization or requirement for an inspection pursuant to Health and Safety  
25 Code sections 39655 (a), 39658 (b) (1) and 41510 (air pollution enforced by the California Air  
26 Resources Board) and Uniform Building Code section 203 (demolition enforced by the Redding  
27 Department of Building and Planning) with respect to the premises names in the caption  
28 above, as required by the Code of Civil Procedure sections 1822.50 et. seq. for the issuance  
29 of an Inspection Warrant,

YOU ARE THEREFORE COMMANDED TO INSPECT, INVESTIGATE, AND SEARCH,  
WHICH INSPECTION SHALL INCLUDE the observation, taking of

1 <sup>5</sup>photographs, taking of video photography, taking samples, and questioning of or conferring  
2 with persons present on the property privately to obtain information bearing on whether  
3 violations of the laws and regulations regarding building demolition and asbestos. Inspection  
4 personnel shall not interfere with the property observation of such investigations;

5 AND THIS INSPECTION shall be reasonably conducted so as to effect as minimal an  
6 intrusion as possible on the normal operations of the property;

7 AND THIS INSPECTION shall be from property boundary to property boundary for  
8 areas specified at:

9 THE PREMESIS located at APN 108-090-02, Pray Road, in the City of <sup>6</sup> Redding,  
10 County of Shasta, State of California, further described as the southwest parcel at the  
11 intersection of Pray Road and Westside Road in the city of Redding, California, assessor's  
12 parcel number (APN) 108-090-02, consisting of a 2.9 acre parcel with a commercial building  
13 facing Westside Road Behind and are approximately 12 small cottage type single family  
14 residences. The commercial building is not included in this warrant as an area to be  
15 inspected.

18 Building materials which may contain asbestos  
19 Including but not limited to stucco, roofing  
20 Felt, pipe insulation which may contain  
21 Asbestos on said property; and to obtain  
22 Samples of any such material.

25 be executed by January 9, 1988.
