Project Plan

The project implementation plan has been developed with input from the Electronic Reporting Work Group noted above. That working group conducted a survey of the UPAs and the received surveys have been compiled to provide information as to the status of the UPAs. About three-quarters of the UPAs have responded as of this time. The chart below displays the major milestones and timeframes for implementing the requirements of the legislation.
