**Site Tour Etiquette and Required Attire:**

The weather during this time of year can range in the high 80's -90's, sunscreen is highly recommended, SPF 30+, hat (large brim, ball cap, visor), long pants, long sleeve shirt, close toe shoes (tennis shoes, hiking boots) are recommended as the terrain will be sandy, gravelly, rocky, pavement (at Compressor Station) as well as grassy brush, shrubs, other vegetation may be encountered. It is recommended that you hydrate before the start of the tour, drink plenty of water. Water, Gatorade, and snacks will be provided during the tour. There is only one Restroom Stop available (Grapevine Canyon).

Please stay close to the tour, DO NOT wander off or detour from the trail as the environment we will visit is in a sensitive area. If you feel the need to pick something up, please replace exactly where it came from. Watch your footing as terrain can be slippery, especially where it is gravelly. Take what you bring in with you, out with you, we will have a receptacle for trash, empty water bottles, etc. Finally .... Enjoy the scenery, respect the places we will be visiting, listen to the land, wildlife and winds as they welcome you to the Traditional homelands of the AhaMakav - "People of the River."
