# FORMAL ENFORCEMENT SUMMARY INSTRUCTIONS

A Formal Enforcement Summary (FES) is to be submitted to the California Environmental Protection Agency (CalEPA) within 30 days after the final disposition, judgment, or agreement of each formal enforcement case is signed. Unified Program Agencies (UPAs) shall submit the FES by email until the information can be collected through the California Electronic Reporting System (CERS).

CUPA – Enter the name of the Certified Unified Program Agency (CUPA) or Participating Agency (PA) that applied the formal enforcement.

DATE SUBMITTED - Enter the date the FES is submitted to CalEPA.

### I. FACILITY IDENTIFICATION

3. BUSINESS NAME – Enter the full legal name of the business. This is the same as the terms Facility Name or Doing Business As (DBA) that might have been used in the past.

103. BUSINESS SITE ADDRESS – Enter the street address or GIS information where the regulated business is located. PO boxes are not allowed. This information must provide a means to identify the regulated business' physical location. 104. BUSINESS SITE CITY – Enter the city or unincorporated area in which the regulated business is located. 105. ZIP CODE – Enter the zip code of the regulated business site.
