Amendment to Hazardous Materials Business Plan and California Accidental Release Prevention Program Regulations California Code of Regulations, Title 19 Explanatory Statement Changes Without Regulatory Effect

The California Environmental Protection Agency ("CalEPA" or "Agency") is proposing to amend and relocate California Code of Regulations, title 19, division 2, chapter 4, sections 2640-2671 including two appendices and chapter 4.5 into a new division with two new articles and two new chapters. CalEPA also proposes to add versions of California Code of Regulations, title 19, division 2, chapter 4, sections 2620, 2621, 2622, and 2630 into the new division in one of the new articles in one of the new chapters. The proposed changes are needed to ensure consistency with existing law, relocate and renumber the regulations, and revise cross-references. As further explained below, CalEPA considers these changes to be changes without regulatory effect.

BACKGROUND

On July 22, 2021, Assembly Bill (AB) 148 (Chapter 115, Statutes of 2021) transferred the responsibility of the Business and Area Plans program, more commonly known as the "Hazardous Materials Business Plan (HMBP)" from the California Governor's Office of Emergency Services (Cal OES) to the Secretary of CalEPA also referred to as the "Secretary for Environmental Protection." In addition, AB 148 transferred the Hazardous Material Management program, more commonly known as the "California Accidental Release Prevention (CalARP) program" from Cal OES to CalEPA. The statutes for HMBP and CalARP are contained in Health and Safety Code division 20, chapter 6.95, articles 1 and 2, respectively.

With the passage of AB 148, revisions to California Code of Regulations, title 19 (Public Safety) are required to reflect the transfer of responsibilities to the Agency and Secretary. These revisions affect Division 2 - California Governor's Office of Emergency Services, Chapter 4 – Hazardous Materials Release Reporting, Inventory, and Response Plans and Chapter 4.5 - California Accidental Release Prevention (CalARP) Program Detailed Analysis. Specifically, CalEPA proposes to change all references in California Code of Regulations, title 19, division 2, chapter 4.5 from "Cal OES" to "Agency." In addition, CalEPA proposes to add a definition for "Agency" and delete the definition for "Cal OES" to ensure clarity. These changes are required because the existing regulatory provisions are inconsistent with and superseded by AB 148 and CalEPA has no discretion to adopt a change which differs in substance from the one chosen.

CalEPA also proposes to relocate and renumber the regulations including appendices and tables in California Code of Regulations, title 19, division, chapters 4 and 4.5 into a new division with two new articles and two new chapters. As a result of these changes, CalEPA proposes to revise cross-references. In addition, CalEPA proposes to revise some cross-references to make them correct. While the changes to California Code of Regulations, title 19 are numerous, they will not materially alter any requirement, right, responsibility, condition, prescription, or other regulatory element.

CHANGES TO REGULATIONS

Existing Chapter 4

CalEPA is proposing to (1) relocate portions of California Code of Regulations, title 19, division 2, chapter 4 into a new division 5 entitled "California Environmental Protection Agency" and a new chapter 1 and (2) add identical versions of California Code of Regulations, title 19, sections 2620, 2621, 2622, and 2630 into the new division 5 in the new chapter 1 as follows and as further explained:

- Article 1. Definitions:
 - Add an identical version of Section 2620 to the new Section 5010.1.

It should be noted that CalEPA is not proposing to relocate or add identical versions of existing Sections 2631 and 2632, which relate to "Spill Release Reporting." AB 148 did not transfer any authority for "Spill Release Reporting" from Cal OES to CalEPA. However, identical versions of Sections 2620, 2621, 2622, and 2630 (which are definitions) are needed as opposed to relocating the sections into the new division 5, chapter 1 because those definitions are needed to provide definitions of terms contained in the HMBP regulations (in the new division 5 and new chapter 1 in California Code of Regulations, title 19) and are also needed for the purpose of Spill Release Reporting that will remain in California Code of Regulations, title 19, division 2, chapter 4.

 - Section 2775.5(b) (new section 5140.6(b)): the reference to "Section 2745.4" needs to be revised to "Section 5070.4."
 - Section 2775.6 (new section 5140.7): the reference to "Section 2735.4" needs to be revised to "Section 5050.4."
 - Section 2775.6(a)(2) (new section 5140.7(a)(2)): the reference to "Section 2735.4" needs to be revised to "Section 5050.4."
 - Section 2775.6(e) (new section 5140.7(e)): the reference to "Section 2734.5" needs to be revised to "Section 5050.4."

In addition, CalEPA is proposing to revise two cross-references to make them correct. Section 2765.2(d) (new section 5120.2) incorrectly refers to "Sections 2731 and 2732 of Title 19 of CCR." Following a 2016 renumbering of title 19 pursuant to California Code of regulations, title 1, section 100 change without regulatory effect, section 2731 became section 2658 (new section 5030.9) and section 2732 became section 2659 (new section 5030.10). However, the cross-references were not revised at that time. As a result, the following cross-references need to be revised as follows:

 Section 2765.2(d) (new section 5120.2(d)): the reference to "Sections 2731 and 2732 of Title 19 of CCR" needs to be revised to "Sections 5030.9 and 5030.10 of Title 19 of CCR."
