Hazardous Materials Business Plan and California Accidental Release Prevention; Guidance Document 24-01

Amendments to Hazardous Materials Business Plan and California Accidental Release Prevention Program Regulations; California Code of Regulations, Title 19 Changes Without Regulatory Effect – "Regulatory Crosswalk"

Effective March 6, 2024, the California Environmental Protection Agency (CalEPA) has amended and relocated California Code of Regulations, title 19, division 2, chapter 4, sections 2640-2671 including two appendices and chapter 4.5 into a new division 5. The creation of a new division 5 has prompted a renumbering of the regulations. The purpose of this guidance is to provide a "regulatory crosswalk" which outlines the numbering of Title 19 prior to and after the amendments became effective. This guidance is not a rule or regulation and does not replace or supersede applicable statutes or regulations. These amendments do not materially alter any requirement, right, responsibility, condition, prescription, or other regulatory element.

Portions of California Code of Regulations, title 19, division 2, chapter 4 have been moved into a new division 5 entitled "California Environmental Protection Agency" and a new chapter 1 and identical versions of California Code of Regulations, title 19, sections 2620, 2621, 2622, and 2630 have been added to the new division 5 in the new chapter 1 as follows:
